

# WAYS TO GIVE

Capital Campaign to Build a Grand Forks Children's Museum & Destination Park

## AREAS OF SUPPORT

1. Children's Museum - Capital Building Fund
2. Children's Museum - Programming & Operations Endowment
3. Destination Park - Feature Playground & Recreation Amenities

### CASH, CHECK, OR CREDIT CARD GIFTS

Make a one-time gift or a pledged gift over multiple years in an amount and duration of your choosing. This gift can be made by cash or credit card and may be set up through an automatic withdrawal if you desire.

### ENDOWMENT GIFTS

Create an endowment with gifts of cash, securities, or marketable assets. Consider supporting the Grand Forks Children's Museum programming and operational endowment.

#### 40% ND TAX CREDIT FOR ENDOWMENTS

An endowment is a perfect way to create a lasting legacy. North Dakota businesses may receive a 40% credit (up to \$10,000) for contributions to our qualified N.D. endowment.

Individuals may receive a state tax credit for a contribution of \$5,000 or more to our endowment. The tax credit is 40% of the charitable deduction, up to \$10,000 per year per taxpayer or \$20,000 per year per couple filing jointly.

### STOCK GIFTS

Donate gifts of appreciated securities to the Grand Forks Children's Museum and you may be eligible for a charitable income tax deduction for the full fair market value of the stock, while avoiding the capital gains tax.

### IRA GIFTS

Donors age 70 1/2 or older can transfer up to \$100,000 annually from their IRA directly to the project without being subject to income taxes on the distribution. Contact your IRA administrator for more information.

### TRIBUTE GIFTS

Make donations in honor or in memory of someone special to the Grand Forks Children's Museum and Destination Park. We will notify the honoree or the family of those memorialized.

### MATCHING GIFTS

Easily double your gift if you or your spouse's employer participates in a matching gift program. If you work for, are retired from, or serve on the board of a company with a matching gift program, please obtain their matching gift form and return it to us to extend the impact of your gift. Contact your human resources department for more information.

### PLANNED GIFTS

Estate gifts, charitable gift annuities, charitable trusts, testamentary endowments and beneficiary designations of life insurance or retirement plan assets are simple yet impactful ways you can leave a legacy while shaping the future of the region.
